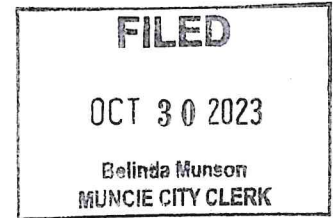

AN ORDINANCE FOR ADDITIONAL APPROPRIATIONS (BEECH GROVE CEMETERY)

WHEREAS, it has been determined that it is now necessary to add additional appropriations for the operations of Beech Grove Cemetery.
