**MUNCIE CITY COUNCIL
ORDINANCE NO. 6-25**

**AN ORDINANCE AMENDING CHAPTER 77 (PARKING REGULATIONS)
OF THE MUNCIE CODE OF ORDINANCES (BURRIS LABORATORY SCHOOL
PARKING)**

WHEREAS, it has been determined that it is necessary to update Chapter 77 – Parking Regulations within the Muncie City Ordinances; and

WHEREAS, the City of Muncie desires to update said chapter of the code to address issues related to parking regulations and enforcement in the area of Burris Laboratory School;

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF MUNCIE, INDIANA AS FOLLOWS:

Section 1. That Chapter 77 – Parking Regulations is amended to add the following section.

Sec. 77.33. Burris Laboratory School permit parking

77.33.010 Definitions.

For the purpose of this section, the following definitions shall apply.

Burris Official is the administrator or other staff administrator at Burris Laboratory School designated to review student parking permit applications.

Student. A person currently enrolled at Burris Laboratory School.

77.33.020 Applicability.

The following zones are designated as Burris Laboratory School permit parking zones:

Street	From	To	Side of Street
Washington Street	College	Nichols	North
Main Street	Talley	Nichols	South
Nichols Ave	Gilbert	Main	East/West

77.33.030 Eligibility.

Each student is entitled to one permit only.

77.33.040 Expiration of permits.

Permits shall expire on July 31st of each year.

77.33.050 Information required on application.

Permits will only be issued to students of Burriss Laboratory School. Enrollment will be verified upon making an application for parking permit.

77.33.055 Review by Burriss Laboratory School

The Burriss Official shall review each permit application prior to the application being submitted to the City. Consideration may be given based on seniority, need, school academic behavior, and attendance performance. The Burriss Official may deny a permit application or revoke a permit due to in-school suspensions, out-of-school suspensions, expulsions, poor academic or behavioral performance, and excessive tardies and/or absences. All applications approved by the Burriss Official shall be forwarded to the City in a prompt manor.

77.33.060 Parking space not guaranteed.

A residential neighborhood parking permit shall not guarantee or reserve the holder an on-street parking space.

77.33.070 Change of Plates.

It is the duty of the permit holder to notify the Burriss Official and the City to update their parking permit whenever there is a change in vehicle license plates. The permit holder must provide the new plate information to the Burriss Official and the City within forty-eight (48) hours of the change to ensure the permit remains valid.

77.33.075 Transfer of ownership of permitted vehicle.

Upon presentation of a previously issued permit and proof of transfer of ownership of the vehicle for which the permit was issued, a student is entitled to a new permit at no charge.

77.33.090 Precedence of no parking zones.

The Burriss Laboratory School permit parking zones do not take precedence over temporary or permanent no parking zones posted by the street department, engineering department, or police department for tree removal, snow removal, street sweeping or other actions deemed necessary by the city.

Section 2. This Ordinance shall be in full force and effect upon its passage by the Common Council, its approval by the Mayor of the City of Muncie and its publication in accordance with the law.


