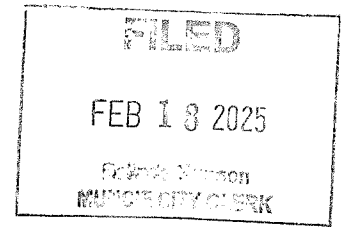

Ordinance 7 -25

**AN ORDINANCE FOR TRANSFER OF APPROPRIATIONS (POLICE/FIRE)**

WHEREAS, it has been determined that it is necessary to make certain transfers within the Police and Fire budget.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF MUNCIE, INDIANA, THAT:

SECTION 1. The following additional sums of money are hereby transferred out of the funds named and for the purposes specified, subject to the laws governing the same. Fund 101 is titled "General Fund" and department 20 is titled "Police Department" and department 21 is titled "Fire Department", Fund 140 "Opioid Distribution" and department 19 is titled "Board of Works".
